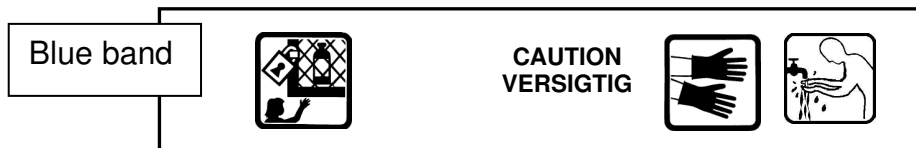

Method of application: After removing the protective strip, the lure should be attached to the roof of the Chempac Yellow Delta Trap. The trap should be hung 1,6 to 1,8 metres above ground level. There should be at least one trap in every two hectares in areas where most moth activity is expected. Traps should be hung in the same position in successive seasons to make comparisons valid.

Traps should be placed in orchards at the beginning of September before moth activity commences. Replace the lures every 6 – 8 weeks. Old lures should be removed from the trap and out of the orchard.

The interpretation of the results should be discussed with a local adviser.

NOTES:

1. The sticky insert of the trap should be kept free of excessive debris by scraping and should be replaced if necessary.
2. The trap should be placed in the tree in such a way that the mouth of the trap is not unduly blocked by foliage.
